Administrative Block comprises of 4 rooms, Principal room, staff & data room etc. needs heavy repair & this block could not be used. Moreover, staff has informed, this block is already declared as **abandoned** by the Competent Authority.

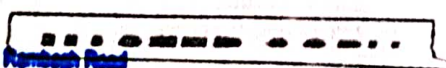

Subject: Regarding Building Structure Safety Certificate.

Reference: Your office Letter No. 153 dated 05.02.2024.

The school building i.e. P.M. SHRI GMSSS Rambagh Road, 07, Ambala Cantt Block – Ambala II has been visually inspected by the SDE P-6 alongwith JE incharge on dated 08.02.2024. The proof checked structural drawings of the building has not been provided by the school Authority during visit. The building is visually found safe. Hence, the school building safety certificate for year 2024 – 25 may be issued with following conditions except old Admn Block Building Marked (A):-

1. Water should not be allowed to stagnate around and on the roof of the Building.
2. If Building is found cracked from anywhere, the same should be got vacated immediately and same should be got repaired immediately.
3. Institution authorities will be responsible for safety of building from every angle and Fire-Fighting equipment's should be in functional condition.
4. If the building of the school is to be extended, the same should be approved from reputed Structural Engineer.
5. Adequate Fire safety may be adopted in the school campus building.
6. Authority will also ensure safety precautions from false ceiling, vitrified floor tiles & PVC paneling if provided.
7. NOC will be treated as cancelled by this office if the School violates any of the above points.
8. Proof Checked structural drawings of the building should be sent to this office for record within 1 month from the issuing of NOC.
